


# Our Mission

# Our **Centers**

The Atlantic Council of Montenegro implements its activities through three of its centers:

## **Digital Forensic Center - DFC**

**Digital Forensic Center** is the first digital hub of its kind in the Western Balkan region devoted to countering disinformation, fake news, and propaganda campaigns that have the goal to destabilize democratic processes and institutions in both Montenegro and the region. The DFC team focuses on key messages found in the Montenegrin and wider information space, which spread altered or completely incorrect information, aiming to discredit and undermine democratic states.





## **Center for International Relations**

**Center for International Relations** aims to enhance cooperation, facilitate dialogue, and advance regional initiatives in the realm of international relations. The Center seeks to catalyze local, regional, and global strategies for promoting more efficient political activities and economic growth. The 2BS Forum is a significant product of the Center's work, serving as the leading politico-security forum in the region that shapes national, regional, and international security frameworks.



## **Center for Countering Terrorism and Violent Extremism**

**Center for Countering Terrorism and Violent Extremism** is committed to providing practical support and multidisciplinary guidelines to strengthen the rule of law and counter extremism that can lead to terrorism activities. Through monitoring and analyzing trends, the Center addresses the root causes of radicalization, changes in extremist and terrorist organizations' methods and techniques, and strategies with a special focus on right-wing extremism in order to build resilience and counter this phenomenon.
